(New York, NY...... June -2013) The mission of DirectWomen is to increase the representation of women attorneys on corporate boards. DirectWomen was an early entrant into the "women on boards" space. Founded in 2007 as a project of the American Bar Association, and with the assistance of Catalyst, DirectWomen's network has grown to include over 100 alumnae, 28 Sandra Day O'Connor Board Excellence Award honorees, and a vibrant group of supporters including academics and luminaries in the legal profession.

Each year, using rigorous selection criteria, DirectWomen selects just 20 remarkably qualified women from a national and competitive pool of applicants. The successful candidates become the year's Class at the DirectWomen Board Institute. These women have been trained as lawyers and are experienced women at the top of their profession. Each year's class represents a diversity of experience from across the business spectrum and across the United States. At the Institute, the class meets with a distinguished faculty to discuss current issues facing boards. The Institute provides a credential of board readiness that supports their election as first time board members.

In just 5 years, twenty percent (20%) of the alumnae of DirectWomen's first four Board Institutes have been elected by important corporate boards. "We are delighted with our success
