PROFILE

Mary W. Quazzo has a successful track record as Vice President, Corporate Secretary and Principal Counsel and as a member of executive leadership at Bechtel Group, Inc., a global engineering, construction and project management company, with over \$17 billion in revenue in 2020. She started in the Legal Department at Bechtel in 1989 and currently serves as a Strategic Advisor to the company. She has substantial experience managing strategic and operational issues, audit and finance, ownership, corporate governance, enterprise risk management, joint ventures and strategic alliances, M&A, compliance, corporate architecture and transactional matters.

Prior to her current role, Mary most recently served as Vice President and Corporate Secretary to the Bechtel Group, Inc. She also served as Principal Counsel and Manager of Corporate Legal, responsible for partnering with other members of executive management to effect corporate strategies on matters impacting worldwide operations. As chief corporate legal advisor, she managed a diverse group of legal, financial and corporate secretarial professionals, accountable for personnel management and professional development, budget and work allocations. Examples of complex matters overseen include:

- Updated company governance structure and practices to increase effectiveness and efficiency of company decision making and oversight and enable succession to non-family CEO for first time in company's 120+-year history and, a few years later, to company's 5th generation family CEO.
- Drafted corporate policy on Governance and an Executive Summary of the governance structure. Updated
 and/or created new board committee charters for the Audit, Finance, Group Strategy, Operating, and Senior
 Management Compensation and Development Committees. Also developed charter for the Bechtel
 Information Security Advisory Group.
- Managed acquisitions and dispositions of interests in numerous companies and structured joint ventures and strategic alliances on several continents to ensure full compliance with Bechtel risk management practices.
 Responsible for compliance associated with corporate aircraft operations.
- Developed and successfully implemented, on a 2-1/2 month schedule, a global capital, entity and tax restructuring plan involving hundreds of entities in 75+ jurisdictions. The reorganization achieved significant long-term operational and tax efficiencies and materially enhanced shareholder value.

- Restructured company's 401(k) plan, which had 15,000+ participants and approximately \$4 billion in assets. The redesigned plan was awarded the Hamilton Award for plan design and is consistently rated as one of the top plans among those with greater than \$1 billion in assets.

 operations. Negotiated joint venture, strategic alliance, guaranty, engineering, procurement, construction,
